



X Important

- Definition of International Students: Anyone with citizenship from a country other than Korea
 Korean citizens who hold dual citizenship are NOT eligible to apply as international students.
- 2. Foreign nationals whose parents are both foreign nationals: The case where both the students and their parents obtain foreign nationality before the students start a curriculum equivalent to the Korean high school also are recognized.
- 3. Korean High School Graduate Equivalency Test, home schooling, cyber schooling, continuing studies or other high school equivalency certificates from Korea or overseas are not recognized as high school diplomas.
- 4. SeoulArts only accepts overseas academic credentials from formal primary and secondary education programs recognized as such by the relevant education laws of the given country.
- 5. Applicants who are unable to meet our requirements (in terms of the duration of enrollment and/or stay) due to COVID-19 are allowed to submit related documentation (original and notarized copies) to have their eligibility reestablished.
- 6. High school graduate candidates must obtain their diploma by February 28, 2025, and high school graduate candidates from Japanese schools must obtain their diploma by March 31, 2025.

% Important for Korean Language Proficiency

- 1. In case of foreign national applicants who have **graduated (or are expected to graduate) from a regular high school in Korea** are exempt from submitting proof of their Korean language proficiency. However, they are required to submit a TOPIK Level 3 or higher within one year of enrollment.
- 2. In case of foreign national applicants who submit a certificate of completion from King Sejong Institute or a score report of Sejong Korean language Assessment or a Korean language institute/school run by a university in Korea, they are required to submit a TOPIK Level 3 or higher within one year of enrollment.
- 3. In case of foreign national applicants who submit a **TOPIK score report of Level 2**, they must complete at least 300 hours of Korean language class in a year at the university after entering the school and submit a score report of level 3 or higher of the TOPIK within a year. In the case of external consignment Korean language class may be charged extra.

- 3. Accepted foreign national students are to submit a bank statement that shows a minimum account balance of **20,000,000 KRW or higher** for one month or longer
- 4. Any record of academic transfer and related transcripts are to be submitted.
- 5. A certificate of family relations must have information on both the applicant and his or her parents.

- 4. You are entirely responsible for any disadvantage that originated from any omissions and errors on your application.
- 5. Any improprieties, such as providing false information on an application form or submitting falsified documents, will count as grounds for disqualification. Your admission or enrollment will be canceled if such misconduct (including plagiarism) is discovered after admission or enrollment or if you fail to meet eligibility requirements (high school graduation, etc.)

E. Refund of Application Fees

- A refund of application fees will be handled as prescribed by Article 42-3 (Admission Fees) of the Enforcement Decree of the Higher Education Act
- ② SeoulArts may not refund the fees if the service fee for online bank transactions is higher than the amount to be refunded.
- ③ SeoulArts refund policy regarding extenuating circumstances such as a conflict in testing schedules due to application to two or more schools.
- Applicants must submit the reason and documentation to the SeoulArts Admissions Office, and we will refund the application fees as follows if the case is deemed reasonable.

7 Practical Skills Test

A. Guidelines for All Applications

1) Video Shooting

- Applicable Majors & Disciplines: Theater, Dance, Acting (first round), Korean Music,

Shoot the video in a single long take from the beginning to the end with no interruptions in-between. (one take video) Shoot the video in an indoor space with a single-tone background, and no additional lighting is allowed other than basic indoor lighting and natural lighting. Avoid shooting the video at a location that may reveal your identity (such as school). Wear the clothes that show the movements of your body clearly. (Do not wear any clothes that may reveal your identity such as school and army uniforms) Make sure not to include any sound from sources other than yourself. (voice of another person, noise made by your companion animal, etc.)
Audition	 For identification purposes, please look straight at the camera with your face and shoulders clearly visible and start with the specified sentence. "2025학년도 정시 서울예술대학교 OO전공 수험번호 OOOOOOOOO번 실기 실연 시작하겠습니다." (check your Eligibility Ticket) Frame the video to show your entire body. * Acting majors are free to perform a monologue and present their special skills but must include a bust shot and a full shot for identification purposes. Complete the video shoot within time limit of each major, including the statement and your performance. Using of musical instruments or MR (music recorded) should be according to each major's guidelines of practical skills test. (Acting Majors are not allowed to use MR or musical instruments. But if you choose musical instruments to show your special ability, it will be allowed.) Submit the file via email: intl2@seoularts.ac.kr


